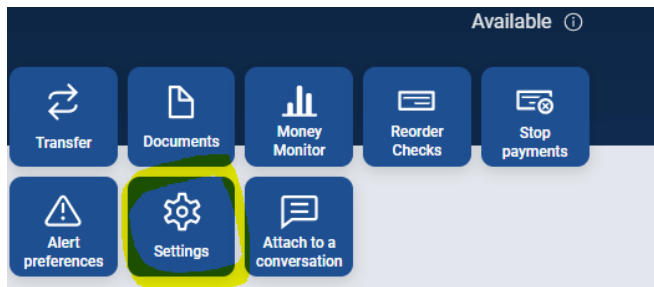


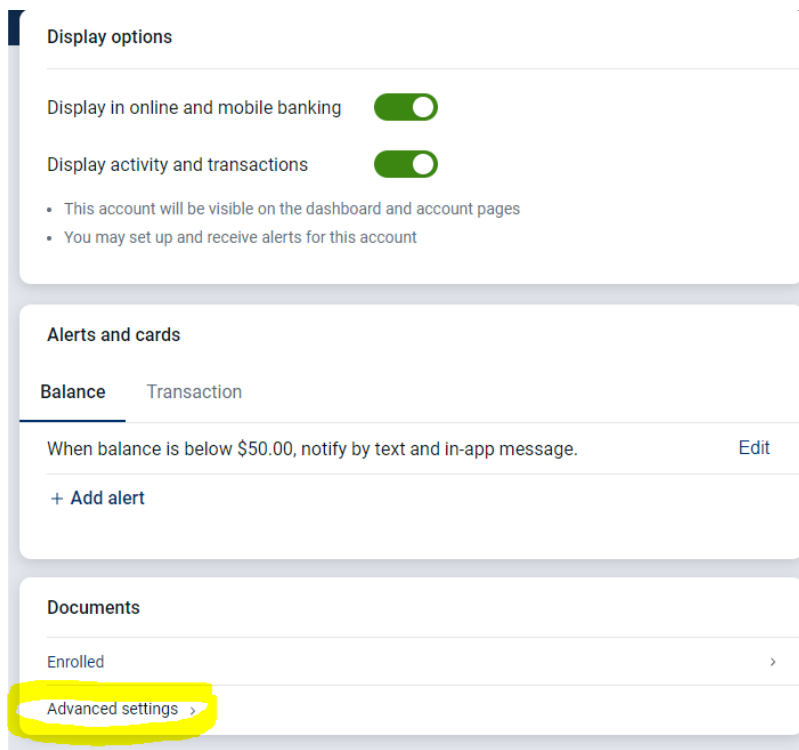
1. On Dashboard tap an account

**PC SPECIFICATIONS.** In order to use this Service, your PC must be equipped with either the current or prior release of Internet Explorer, Firefox, Google Chrome or Safari. Each time a new version is released the third oldest version will no longer be supported. The browser must support SSL encryption. To view Electronic Documents, your PC must be equipped with Adobe Professional Reader or Acrobat, versions 10.0 and higher.

**This Online Statement Agreement ("Agreement")** applies to all checking, savings and money market accounts ("Account") you have with American National Bank. By choosing to receive an American National Bank Electronic Statement ("Electronic Statement") you will receive statements for the accounts you elect. If you receive a combined statement, you will receive the combined statement electronically, regardless if you have elected to receive both statements electronically. **Once you enroll in Electronic Statements you will no longer receive a paper statement.** Check and check images normally received with your paper statement will also be discontinued. Please note that check images will continue to be available in the Transaction screen of American National Bank Internet Banking.

**If you no longer wish to receive Electronic Statements for a particular Account, you can revert to paper statements by un-checking the particular Account within the Electronic Statement tab.** The Electronic Statement tab is visible upon logging in to American National Bank Internet Banking. For combined statements, the primary account must be un-checked to allow paper statements to begin again. Your primary account is the first account presented on your combined statement. Some statements may also include detailed line of credit information for your Overdraft Protection Lines. Should you have questions regarding this information, contact American National Bank at 612-238-4800.

Paper copies of statements can be requested by calling the bank. A request for an individual statement will be provided at no cost. For large requests you may be subject to the bank's current research fee. You may inquire on what the exact cost will be when requesting the statement(s).

The words "we", "us" and "our" mean American National Bank and the words "you" and "your" mean you, the individual who is identified on the Account as the owner or authorized signer on the Account(s). As used in this Agreement, "Disclosure" means any account statement, authorization, agreement, disclosure, notice, or other information related to your Account including, but not limited to, information that we are required by law to provide in writing.

**1. DISCLOSURES WE WILL PROVIDE TO YOU ELECTRONICALLY** (when you activate Online Statements associated with your Account(s)), you agree that we may provide you with any Disclosures relating to your Account(s) in electronic format, and that we will discontinue sending paper Disclosures to you. We will only provide Disclosures to you electronically unless and until you withdraw your consent as described below. Your consent to receive Disclosures electronically includes, but is not limited to:

- Account statements and related Disclosures;
- Initial Disclosures or agreements for your Account(s) or associated payment features;
- notices or Disclosures about a change or amendments in the terms of your Account(s) or associated payment feature;
- privacy policies and privacy statements.

**2. HOW WE WILL PROVIDE DISCLOSURES ELECTRONICALLY**

All Disclosures will be provided to you electronically in one of several ways. These are either:

1. by e-mail at the most current address we have on record;
2. by access to a website that we will identify in an e-mail notice we send to you at the time the information is available; or
3. the extent permissible by law, by access to a website that we will identify in advance for such purpose.

You may view the e-mail address we have on file in the Options tab under Personal. Your e-mail address will appear in the box next to e-mail address. To update it, type your current e-mail address in the open box to the right of your current one and click submit.
